- I understand that, as a participant in the Merrimack GRAD Advantage program, I am eligible to have two graduate courses covered by the GRAD Advantage scholarship during my senior year of undergraduate studies. The value of the scholarship can vary, and the final amount I receive will be determined by the number of graduate credits taken senior year. If fully utilized for courses taken senior year, the scholarship will no longer apply after graduation.
- If I do not utilize the full value of this scholarship during my undergraduate studies, the scholarship will be offered during my graduate studies and prorated based upon my credit load at that time.
- I understand that it is my responsibility to inform the Office of Financial Aid if my credit load changes at any point during the academic year, as this directly impacts my scholarship amount.
- I understand that I must earn a B or better in each of the graduate courses I take during my senior year.
